**NOTICE OF RATE CHANGE  
AZIMUT LEGAL DOCUMENTATION SERVICE**

Dear Client,

The Société québécoise d'information juridique (SOQUIJ) would like to inform you of rate changes for AZIMUT, online legal documentation service, in accordance with section 8 of the User Licence. **These changes will come into effect on January 1, 2008.**

Since its inception in 1999, AZIMUT has been constantly developing and expanding its services. Recently, SOQUIJ has included new jurisdictions in Juris.doc: the Discipline Committee of the Chambre de l'assurance de dommages (the Quebec insurance brokers' association), the Public Service Staffing Tribunal, and the Commission des relations du travail (Quebec labour relations board). Scholarly commentary and case histories have also been added. In addition, AZIMUT now offers exclusive access to the minute books of municipal courts through our Plumitifs service.

SOQUIJ has also made it easier to consult our databanks by introducing the new Thesaurus feature and by upgrading the search management tools and Plumitifs. And this coming year, our clients can look forward to new functions such as multi-bank searching.

All of these improvements are the result of our continued commitment to meeting your legal information needs.

Monthly subscription rates to AZIMUT, legal documentation service will be \$12 per access code for the first five codes. Additional codes will be free of charge.
